2. A relaxation of 5% may be provided, from 55% of the marks to the Ph.D. degree holders, who have obtained their Master' Degree prior to 19th September, 1991

Secondary/Sr. Secondary or equivalent grades in the point scale wherever grading system is followed without including any grace marks and / or rounding off to make it 55% or 50% as the case may be".
